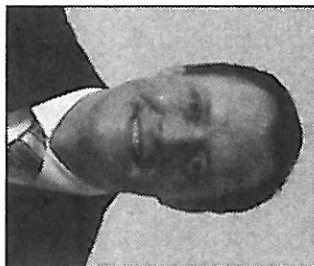

... Greg Young has joined Okin Adams & Kilmer in Austin as a partner.

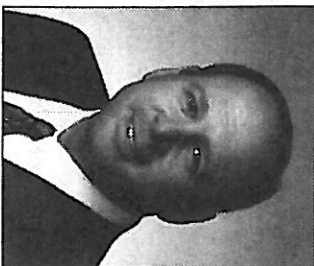
Alex J. Brown, E.F. "Mamo" DeAyala and Vianei Lopez Robinson have joined Buck Keenan in Houston as partners.
